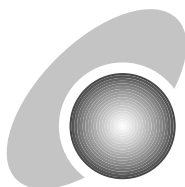

PROPOSALS FOR GENERAL MANDATES TO ISSUE AND REPURCHASE SHARES AND RE-ELECTION OF DIRECTORS AND NOTICE OF ANNUAL GENERAL MEETING

INTRODUCTION

The purpose of this document is to provide the Shareholders with details regarding the proposed granting of general mandates to the Directors to issue and repurchase Shares and the proposed re-election of the retiring Directors. Such proposals will be dealt with at the Annual General Meeting.

GENERAL MANDATES

At the Annual General Meeting, separate ordinary resolutions will be proposed to renew the general mandates given to the Directors (i) to allot, issue and otherwise deal with Shares not exceeding in aggregate 20% of the aggregate nominal amount of the share capital of the Company in issue at the date of the passing of such resolution; (ii) to repurchase Shares comprising the aggregate nominal amount of which does not exceed 10% of the aggregate nominal amount of the issued share capital of the Company at the date of passing of such resolution; and (iii) to add the aggregate amount of the Shares repurchased by the Company to the general mandate to the Directors to allot new Shares of up to 20% of the issued share capital of the Company.

The mandates to issue Shares and repurchase securities granted at the annual general meeting held on 30th September, 2005 will lapse at the conclusion of the Annual General Meeting. Resolutions nos. 4A to 4C set out in the notice of Annual General Meeting will be proposed at the Annual General Meeting to renew these mandates. With reference to these resolutions, the Directors wish to state that they have no present intention to repurchase any Shares or to issue any new Shares pursuant to the relevant mandates.

The explanatory statement, required by the Listing Rules to be sent to Shareholders in connection with the proposed Repurchase Mandate is set out in the Appendix to this document. This contains all the information reasonably necessary to enable Shareholders to make an informed decision on whether to vote for or against the relevant resolutions.

ANNUAL GENERAL MEETING

A notice of the Annual General Meeting is set out in this document. At the Annual General Meeting, in addition to the ordinary business, resolutions will be proposed to approve the general mandates for the issue and repurchase by the Company of its own Shares respectively.

LETTER FROM THE BOARD

Details of the Directors who are proposed to be re-elected at the Annual General Meeting are as follows:

Mr. CHEUNG Wing Yin, Vigny Wiley, aged 44, is an Executive Director of the Company and also holds directorship in certain Subsidiaries. He joined the Group in 1998 and is responsible for retail operations of the Group and heads up the Macau Office and MIS Department. Mr. CHEUNG holds a Bachelor of Science Degree from the University of Toronto, Canada. He has over 13 years of experience in sales and marketing of engineering products. Mr. CHEUNG has not held any directorship in other listed public companies during the last three years. Save as disclosed, Mr. CHEUNG does not hold any position with the Company or other members of the Group. Pursuant to the service contract entered into between Mr. CHEUNG and the Company, Mr. CHEUNG's appointment is for a term of two years which may be terminated by prior written notice. Under the service contract, Mr. CHEUNG is entitled to a monthly salary of HK\$40,800 and discretionary bonus which the Board may determine having regard to the performance of the Director and/or the operating results of the Group. Such remuneration is determined with reference to the Director's experience, duties and market trend. Mr. CHEUNG is not connected with any Directors, senior management or substantial or controlling shareholders of the Company. Mr. CHEUNG is interested in 10,000,000 Shares within the meaning of Part XV of the Securities and Futures Ordinance. Save as disclosed above, there are no other matters that need to be brought to the attention of the Shareholders. Pursuant to the Articles, Mr. CHEUNG will retire from office by rotation at the Annual General Meeting and he will be eligible for re-election.

Mr. WAN Kwok Cheong, aged 47, is an Executive Director of the Company and also holds directorship in certain Subsidiaries. He joined the Group in 2000 and is responsible for the customer relationship and business development of the Group. Prior to joining the Group, Mr. WAN was an elected Director for the Real Estate Board of Great Vancouver in Canada and had served on the Board's business practices and administration. Mr. WAN has over 19 years of experience in the sales and marketing industry. Mr. WAN has not held any directorship in other listed public companies during the last three years. Save as disclosed, Mr. WAN does not hold any position with the Company or other members of the Group. Pursuant to the service contract entered into between Mr. WAN and the Company, Mr. WAN's appointment is for a term of two years which may be terminated by prior written notice. Mr. WAN will not receive any director's fee. Mr. WAN is not connected with any Directors, senior management or substantial or controlling shareholders of the Company. Mr. WAN is interested in 11,000,000 Shares within the meaning of Part XV of the Securities and Futures Ordinance. Save as disclosed above, there are no other matters that need to be brought to the attention of the Shareholders. Pursuant to the Articles, Mr. WAN will retire from office by rotation at the Annual General Meeting and he will be eligible for re-election.

LETTER FROM THE BOARD

Mr. KO Wai Lun, Warren, aged 38, is a Non-executive Director of the Company since 2003. He was a partner of Richards Butler, an international law firm, between 2001 and 2005. Mr. KO is currently a partner at the law firm, Robertsons and specialises in corporate finance work including initial public offerings, mergers and acquisitions and restructuring. Educated in England and Canada, Mr. KO obtained his Bachelor of Science Degree from Simon Fraser University in Canada and Bachelor of Laws Degree in England. He is qualified to practise law in both England and Wales and Hong Kong. Mr. KO has not held any directorship in other listed public companies during the last three years. Save as disclosed, Mr. KO does not hold any position with the Company or other members of the Group. Pursuant to the service contract entered into between Mr. KO and the Company, Mr. KO's appointment is for a term of one year which may be terminated by either party giving to the other one month's written notice. Mr. KO receives a director's fee of HK\$35,000 per month which is determined with reference to his experience, duties and market trends. Mr. KO is not connected with any Directors, senior management or any substantial or controlling shareholders of the Company. Mr. KO is not interested in any Shares within the meaning of Part XV of the Securities and Futures Ordinance. Save as disclosed above, there are no other matters that need to be brought to the attention of the Shareholders. Pursuant to the Articles, Mr. KO will retire from office at the Annual General Meeting and he will be eligible for re-election.

A form of proxy for the Annual General Meeting is enclosed herewith. Whether or not you intend to be present at the Annual General Meeting, you are requested to complete the form of proxy and return it to the Company's head office and principal place of business in Hong Kong at 16th Floor, ICBC Tower, Citibank Plaza, 3 Garden Road, Central, Hong Kong in accordance with the instructions printed thereon as soon as practicable but in any event no later than 48 hours before the time appointed for holding the Annual General Meeting. The completion and return of the form of proxy will not preclude you from attending and voting in person at the Annual General Meeting or any adjourned meeting should you so wish.

Pursuant to Article 80 of the Articles, a resolution put to the vote of a general meeting shall be decided on a show of hands unless (before or on the declaration of the result of the show of hands or on the withdrawal of any other demand for a poll) a poll is duly demanded by the Chairman or by:

- (a) at least 5 Shareholders present in person or by proxy and entitled to vote at the meeting; or
- (b) any Shareholder or Shareholders present in person or by proxy and representing in aggregate not less than one-tenth of the total voting rights of all Shareholders having the right to attend and vote at the meeting; or
- (c) any Shareholder or Shareholders present in person or by proxy and holding Shares conferring a right to attend and vote at the meeting on which there have been paid up sums in the aggregate equal to not less than one-tenth of the total sum paid up on all Shares conferring that right.

RECOMMENDATION

The Directors consider that the proposed granting of general mandates to the Directors to issue and repurchase Shares and the proposed re-election of Directors are in best interests of the Company and the Shareholders as a whole. Accordingly, the Directors recommend all Shareholders to vote in favour of the ordinary resolutions to be proposed at the Annual General Meeting in respect thereof.

The following is the explanatory statement required to be sent to the Shareholders under the Listing Rules in connection with the Repurchase Mandate proposed to be passed by the Shareholders by an ordinary resolution at the Annual General Meeting.

1. SHARE CAPITAL

It will be proposed at the Annual General Meeting to be held on Friday, 3rd March, 2006, an ordinary resolution to grant the Repurchase Mandate to the Directors up to 10% of the Shares in issue as at the date of the passing of such resolution.

As at the Latest Practicable Date, the authorised share capital of the Company was HK\$200,000,000 divided into 20,000,000,000 Shares, of which 5,165,973,933 Shares were in issue. There were 101,800,000 outstanding options granted under the Old Share Option Scheme to subscribe for up to 101,800,000 Shares. On such basis (and assuming no further Shares are issued or repurchased by the Company prior to the Annual General Meeting), the Directors would be authorised to repurchase up to 516,597,393 Shares.

In the event that all the subscription rights attached to the options are exercised in full on or before 5:00 p.m. on Thursday, 2nd March, 2006 by the holders of options granted under the Old Share Option Scheme, the number of Shares in issue will be increased to 5,267,773,933. On the basis of such figure (and assuming no further Shares are issued or repurchased by the Company prior to the Annual General Meeting), the Directors would be authorised to repurchase 526,777,393 Shares.

2. REASONS FOR THE REPURCHASE

The Directors believe that it is in the best interests of the Company and its Shareholders for the Directors to have a general authority from the Shareholders to enable the Directors to purchase Shares on the market. Such repurchases may, depending on market conditions and funding arrangement at the time, lead to an enhancement of the net asset value of the Company and/or its earnings per Share and will only be made when the Directors believe that such repurchases will benefit the Company and the Shareholders.

3. FUNDING OF REPURCHASES AND IMPACT ON REPURCHASES

Repurchases must be made out of funds which are legally available for such purpose in connection with the memorandum and articles of association of the Company and the laws of the Cayman Islands. It is envisaged that the funds required for any repurchases would be derived from the distributable profits of the Company.

There may be material adverse impact on the working capital or gearing position of the Company (as compared with the position disclosed in its most recent published audited accounts for the year ended 30th September, 2005) in the event that the proposed repurchases of Shares were to be carried out in full at any time during the proposed repurchase period. However, the Directors do not propose to exercise the Repurchase Mandate to such extent as would, in the circumstances, have a material adverse effect on the working capital of the Company or its gearing level which in the opinion of the Directors is from time to time appropriate for the Company.

5. GENERAL

No connected persons (as defined in the Listing Rules) of the Company have notified it of a present intention to sell Shares to the Company and no such persons have undertaken not to sell any such Shares to the Company in the event that the Repurchase Mandate is granted by the Shareholders.

There are no Directors or (to the best of the knowledge of the Directors, having made all reasonable enquiries) any associates (as defined in the Listing Rules) of the Directors of the Company who have a present intention, in the event that the Repurchase Mandate is granted by the Shareholders, to sell Shares to the Company.

The Directors have undertaken to the Stock Exchange to exercise the power of the Company to make purchases pursuant to the Repurchase Mandate in accordance with the Listing Rules and the laws of the Cayman Islands.

If as a result of a share repurchase a Shareholder's proportionate interest in the voting rights of the Company increases, such increase will be treated as an acquisition of voting rights for the purposes of the Takeovers Code. As a result, a Shareholder or a group of Shareholders acting in concert could obtain or consolidate control of the Company and thereby become obliged to make a mandatory offer in accordance with Rule 26 of the Takeovers Code.

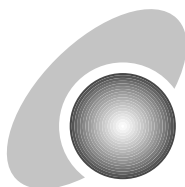
As at the Latest Practicable Date, according to the register kept pursuant to the Section 336 of the Securities and Futures Ordinance, Optimum Pace International Limited, which holds approximately 57% of the issued share capital of the Company, is the only substantial shareholder of the Company holding more than 5% of the issued share capital of the Company. As such, no matter to what extent the Directors exercise the power to repurchase Shares pursuant to the Repurchase Mandate, Optimum Pace International Limited will not be obliged to make a mandatory offer under Rule 26 of the Takeovers Code.

Save as disclosed above, the Directors are not aware of any consequences which could arise under the Takeovers Code as a consequence of any purchases made pursuant to the Repurchase Mandate.

6. REPURCHASES MADE BY THE COMPANY

The Company has not repurchased any of its securities (whether on the Stock Exchange or otherwise) in the six months preceding the Latest Practicable Date.
